**CASKET BURIAL** I/We understand that Maritime Burials will prepare the casket to Naval/Coastguard guidelines for casketed burial at sea which will include physical modifications, added weight and banding as required for proper submersion and delivery to the sea floor. Furthermore, said casket will remain discreetly covered and un-viewable throughout the transportation, service and up to water deployment.

**SHROUD BURIAL** I/We understand the deceased will be securely wrapped in cotton sail canvas (duck cloth) with additional weight for proper submersion, delivery to the sea floor and secured externally with cloth belting or sisal cord. The shrouded body will be transported and deployed into the ocean by use of a rental casket or similar device.

I/We understand that the deceased remains are unrecoverable once interred in the ocean.

The obligation of Maritime Burials shall be limited to the interment of the casketed or shrouded remains of the Deceased as directed herein. I/We agree to release and hold Maritime Burials, its affiliates and their agents, employees, successors and assigns harmless from any and all loss, damage, liability or causes of action (including attorney's fee and expenses of litigation) in connection with the interment/disposition of said remains of the Deceased as authorized herein or respect to the Identification of said remains as being those of the Deceased.
